A. PLEDGE TO THE FLAG

C. CERTIFICATION OF MEETING NOTICE AND AGENDA POSTING

City Clerk Tamura confirmed that the meeting was properly posted.

D. CLOSED SESSION ANNOUNCEMENT

City Attorney Barrow announced that there were two Closed Session items: on Item No. 1 (Conference with Labor Negotiator) the City Council gave direction to the negotiator. On Item No. 2 (Conference with Legal Counsel {Existing Litigation}) the City Council unanimously voted to authorize a settlement and the terms are: that Geoff Dolan will pay the city \$38,800 and dismiss his lawsuit and each party will pay its own costs. This settlement is a very well earned victory for the city which stood firm against the lawsuit without any further expenditure of public money. This agreement requires Mr. Dolan to dismiss the lawsuit and make a substantial payment to the city. There are three factors involved in this decision to bring this litigation to an end. First, without any further cost and expense, the city will recoup \$38,800 of the \$45,187 awarded to the city. Collection of this judgment would otherwise have been costly as the city was forced to pursue collection in two states: California and Colorado, where Mr. Dolan currently lives. Second, this agreement awards the cost and risk of defending the city's victory on appeal. The cost of appeal is estimated at \$50,000. Finally and most importantly, this agreement brings closure to the litigation and allows the city, its residence and city staff to move forward. There were no other reports or action taken and that concludes the report on the closed session.
