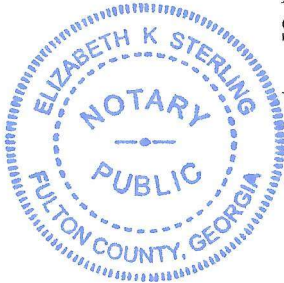

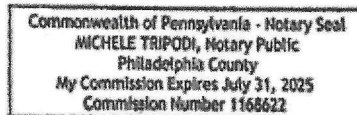

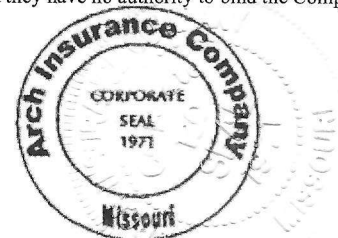

2. PlanetBids, Mandatory Pre-Bid Meeting, and PM emailed Questions

- a) **Question:** On the plans, (R) shows cameras to be removed and replaced to specified but there are a few that do not show what to replace it to? Do we just use our best judgment on this?
- b) **Response:** Where the drawings show (R), the general notes state replace "...with axis model P3267-LV or equal...", however that should be **Avigilon model 6.0C-H5A-D01-IR**. Note, for (R) cameras field of view will need to be coordinated with City Staff.
- c) **Question:** The Notice Inviting Bids (NIB) states that "Each Bidder shall possess a valid Class "A" Contractor's license, would a Class B coupled with Class C-7 and C-10, or a C-10 electrical license, or a C license suffice or acceptable?
- Response:** Refer to Addendum No. 1, which updated the license requirement to "Each Bidder shall possess a valid and applicable Class "C" Contractor's license...at the time of the Bid submission."
- d) **Question:** Will the pre-bid meeting sign in sheet be posted or made available?
- Response:** Item 1 of this Addendum (No. 2) provides the attendees of the mandatory pre-bid meeting.
- e) **Question:** Will the City disqualify any bidders who were absent or late for the mandatory pre-bid meeting sign in at 10 am?
- Response:** To qualify for award of this construction contract, bidders must have attended the mandatory pre-bid meeting and site visit held on August 8, 2023. Bids received from bidders that failed to attend, or attended too late to adequately view the facilities, may be deemed non-responsive by the City. Additionally, the NIB states, "No allowances for cost adjustments will be made if a Bidder fails to adequately examine the Project site before submitting a Bid."
- f) **Question:** Does the underground parking lot slab contain post-tension cables? If so will the city handle x-raying of slab prior to core drilling through slab?
- Response:** Core drilling through slab is not anticipated for this project, however if necessary the City will coordinate with the awarded contractor to do any x-raying of the slab prior to any core drilling.
- g) **Question:** Why was the estimated bid value adjusted from \$882,322 to **\$514,884**? Does the bid value include the cost of a Maintenance Contract/Agreement?

Response: Construction management, inspection, City purchases, and other costs were originally included in the Estimated Bid Value. The updated Estimated Bid Value is for this construction contract only and does not include the cost of a Maintenance Contract/Agreement.

h) **Question:** Are there pre-determined location for the tie-ins?

Response: Yes, each site location has an existing location for the tie-ins.

i) **Question:** Is there a frame per second requirement?

Response: Yes, it is noted in the Project Specifications under Section 28 2300, Article 1.08, Subparagraph C.4: The system shall be capable of displaying and recording individual video inputs at variables frame rates 1 to 30 frames per second (fps). The system shall be configured to allow a combination of any and all cameras to be recorded at 15 fps at the highest rated resolution of the cameras simultaneously.

j) **Question:** Do the plans show Cat 6 or Cat 6A?

Response: Cat6A is preferred.

k) **Question:** Will the installation in the exterior be rigid or EMT?

Response: Exterior installations are dependent on weather exposure, refer to Specification Section 26 0500, Article 3.02, Paragraph A for requirements.

l) **Question:** If we need a lift is there a place to store it or will the contractor be responsible to find a location?

Response: The City can work with the contractor to provide limited storage, if needed.

m) **Question:** Moreover for the "E" Existing to remain, are we adding licenses for these cameras to the New Avigilon Server?

Response: For (E) cameras, yes we will be adding licenses for these cameras to the new server.

n) **Question:** What Server would you like us to quote, and how many days of video retention?

Response: For server requirements, refer to Specification Section 28 2300, Article 2.02, Paragraph C and D. For storage requirements, refer to Specification Section 28 2300, Article 1.08, Paragraph D, Subparagraph 4.c.

o) **Question:** Is it acceptable to quote Ubiquiti Pro PoE Switches?

Response: Yes, as long as the switches meets the requirement outlined in specifications. However network switches are existing and coordination of available ports will be required with City's IT Department.

p) **Question:** Avigilon no longer carries 180° Cameras only 270's and 360's. The 270's will also work as 180°, is that OK?

Response: Using 270° cameras that also works as 180° is acceptable.

q) **Question:** Some Cameras have "MI-F" we cannot seem to find what that type of resolution that is?

Response: MI-F cameras shall be EHD 4-imager cameras. Refer to Specification Section 28 2300, Article 2.03, Paragraph E.4.

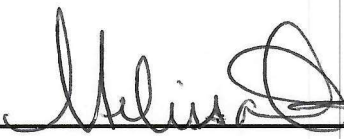
