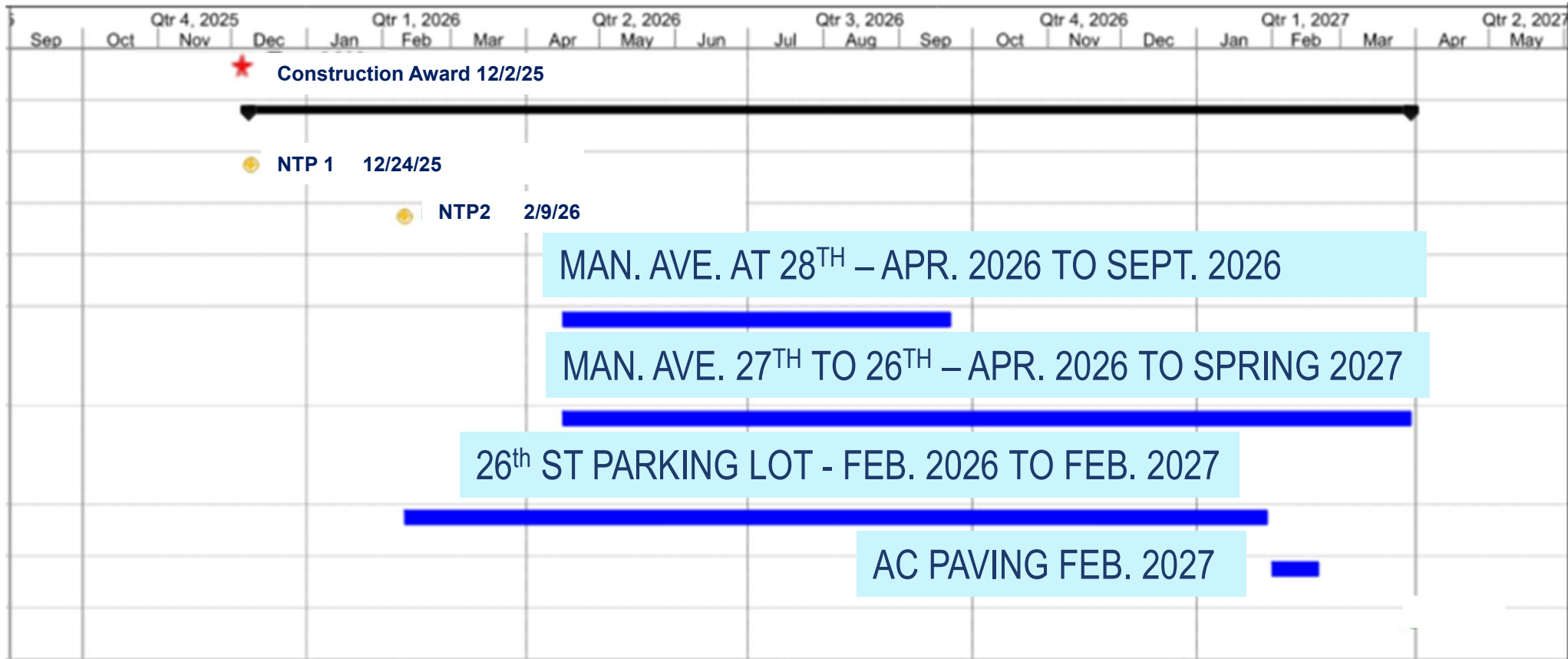
CONSTRUCTION ENG SUPPORT
