#### **PRESENT**

Mayor Lesser announced that the Annual Memorial Blood Drive, traditionally held during the Manhattan Beach Hometown Fair, will still take place during the Fair weekend; however, this year it will be held at a new location, the Manhattan Beach Library; the event is scheduled for Saturday, October 4, 2025, and Sunday, October 5, 2025, from 10:00 AM to 4:00 PM; he emphasized the enormous need for blood donations, whether for infusions, planned surgeries, or cancer treatments; and noted that in recent years, there has been a shortage, making this blood drive, among others, incredibly important to support the community's healthcare needs.

Memorial Blood Drive Chairman Michael Archuleta shared that over the 25 years of the blood drive, 1,363 units of usable blood have been donated through 1,440 donors; and announced that they also wished to honor Matt's father, who passed away last year due to cancer; and therefore, the memorial blood drive is now officially named the Matt and Mike Johnson Memorial Blood Drive.

On behalf of the City Council, Mayor Lesser presented a Certificate of Recognition to Michael Archuleta on the 25th Annual Matt and Mike Johnson Memorial Blood Drive.

Waste Management Recycling Education Representative Bobby Bell shared that he had the opportunity to present to seniors at the Joslyn Community Center last Tuesday, where he provided recycling tips and answered questions; and reminded the community that the final Free Paper Shredding event of the year will be held at Mira Costa High School on October 18, 2025, from 9:00 AM to 11:00 AM.

Police Chief Rachel Johnson invited the community to attend the upcoming Town Hall meeting at the Joslyn Community Center on September 18, 2025, from 6:00 PM to 8:00 PM.

Library Manager Cassandra Sargent invited the community to attend several upcoming events, beginning with tomorrow's in-person program "Why Dolphins Surf?" at 6:00 PM; announced the New Parent Engagement program, scheduled for September 22, 2025, which will introduce new parents to the library's programs and services; and announced the Susie Hansen Latin Trio Band will perform at the library on September 23, 2025.

City Manager Talyn Mirzakhanian announced the appointment of the City's new Community Development Director and introduced Masa Alkire.

Community Development Director Masa Alkire expressed his excitement about joining the City and shared that he looks forward to serving the community in his new role. He noted that he previously served as the City Planner Assistant Director of Community Development for the City of Beverly Hills, and prior to that, held positions with the City of El Segundo and worked as a consultant.

Mira Costa High School students Ryan Beaupain, Founder and President of the Digital Philanthropy Club, and Luke Finigan, Vice President, shared that they established the club with a mission to recycle e-waste and support youth education in underserved communities. They noted that the club has grown to over 25 members and has engaged many Mira Costa students in volunteer efforts.
