

AMENDMENT NO. 3 TO THE DESIGN SERVICES AGREEMENT BETWEEN THE  
CITY OF MANHATTAN BEACH AND SA ASSOCIATES, INC.

This Third Amendment ("Amendment No. 3") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and SA Associates, Inc. a California corporation ("Consultant") (collectively, the "Parties") is hereby entered into as of May 17, 2022 ("Effective Date").

RECITALS

- A. On May 21, 2019, the City and Consultant entered into an agreement for professional services for the Consultant to provide engineering design services for the Sewer Infrastructure Improvement Project ("Original Agreement");
- B. On November 18, 2019, the City and Consultant entered into Amendment No. 1 to the Original Agreement to increase the Maximum Compensation and modify the Scope of Services.
- C. On June 21, 2021, the City and Consultant entered into Amendment No. 2 to extend the Term. The Original Agreement, as amended by Amendment No. 1 and Amendment No. 2, is referred to as the "Agreement."
- D. The Parties now desire to amend the Agreement to extend the Term, increase the Maximum Compensation, and modify the Scope of Services.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

- 1. Section 2 of the Agreement is hereby revised to extend the Term of the Agreement through June 30, 2024, unless sooner terminated as provided in Section 12 of the Agreement.
- 2. Section 3.A of the Agreement is hereby revised to increase the Maximum Compensation amount by \$194,000, for a new Maximum Compensation of \$406,500.
- 3. Exhibit A (Scope of Services) of the Agreement is hereby amended to include additional services by adding the services set forth in the attached Exhibit A (Scope of Services). Exhibit B (Approved Fee Schedule) of the Agreement is hereby amended by adding the attached Exhibit B (Approved Fee Schedule).
- 4. Except as specifically amended by this Amendment No. 3, all other provisions of the Agreement shall remain in full force and effect.
