

## BCT Line 109 Cost Sharing Proposal: July 2016-2017

March 2016

Service Beach Cities Transit operates the Line 109 route with agency partners, including RedondoOverview Beach, Hermosa Beach, Manhattan Beach and El Segundo. The partner agencies share operating costs for Line 109.

Update: Three new buses were placed in service in January 2015. Also, new BCT flag signs were installed, and At Stop Panel signs were installed at key bus stop locations along the Line 109 route. The At-Stop Panel signs illustrate destination information, the time schedule for the specific bus stop, as well as the travel time from the specific stop to destinations along the Line 109 route.

Proposed: City staff is in progress of setting up BCT service information for trip planning on Google Transit, which is projected to be active in May 2016. The City Council has approved the use of Twitter for BCT services which is planned to be live by June 2016.

Statistics: BCT Line 109 passenger trips decreased in FY 2014-15 by 3%, with 6,386 fewer trips over the prior year. Fare revenues were commensurate to the passenger trips at 3%, or \$5,036 shortfall.

Service Statistics History of BCT Line 109

Metro's annual transit formula funding allocations to municipal transit operators is based on sales tax revenue receipts. Regional funding estimates stayed relatively stable, however annual operations funding under the State Transit Assistance Program decreased by approximately \$52,000 for FY 2016-17. This decrease is due to the California State Controller's Office recent interpretation of State Transit Assistance (STA) program funding. The changes to the allocation added more than 100 new transit entities to the list of agencies for which the Controller calculates revenue, resulting in less funding to the existing transit agencies.

CostThe expenses included in the cost sharing estimates for BCT Line 109 are the<br/>operating expenses incurred by the transit contractor and fuel expenses, which<br/>are expected to be \$1,231,205 for the operation of 20,306 projected annual

Fiscal Yearservice hours. Cost increases are the result of increased fuel expenses and the2016transit contractor annual operating increases.

Investment Based on the preliminary fund marks issued by Metro in March 2016, the estimates estimated FY 2016-17 shortfall for the BCT Line 109 is estimated at \$134,455. Dedicated Transit Funding remains stagnant for the majority of Formula Funding, and changes to the State Transit Assistance (STA) funding results in overall reduction in Transit Fund allocations.

The Cities' cost sharing agreement is a two-year period (FY 2015-16 and FY 2016-17), that set a contribution cap increase of 10% for Hermosa Beach, Manhattan Beach and El Segundo. City Council approval was granted by Hermosa Beach and El Segundo, valid until FY 2016-17. The Manhattan Beach City Council approved a one-year agreement; the FY2016-17 must be negotiated prior to June 30, 2016.
