

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF MANHATTAN BEACH AND HF&H CONSULTANTS,
LLC

This First Amendment ("Amendment No. 1") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and HF&H Consultants, LLC, a California limited liability corporation ("Consultant") (collectively, the "Parties") is hereby effective as of August 19, 2025 ("Effective Date").

RECITALS

A. On June 4, 2024, the City and Consultant entered into an agreement for professional services ("Agreement") for the Consultant to provide on-call as-needed contract services related to the franchise agreement with Waste Management, the City's hauler.

B. The Parties now desire to amend the Agreement to increase the Maximum Compensation amount by \$20,000.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

Section 1. Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$20,000, for a new Maximum Compensation amount of \$ 94,900.

Section 2. Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.
