- <u>Section 1.</u> Section 3.A of the Agreement is hereby revised to increase the Maximum Compensation amount by \$144,700.00, for a total Maximum Compensation of \$193,690.
- <u>Section 2.</u> Exhibit A, Scope of Services and Approved Fee Schedule of the Agreement is hereby modified by the Scope of Services and Approved Fee Schedule A-1 attached to this Amendment.
- <u>Section 3.</u> Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.
