## CITY OF MANHATTAN BEACH NOTICE OF PUBLIC HEARING FOR SOLID WASTE SERVICE RATE INCREASE

The City of Manhattan Beach City Council will hold a public hearing on July 7, 2015 at 6:00 PM, in City Council Chambers to consider an increase to the solid waste service rate.

### Why am I receiving this notice?

On March 4, 2015, the City Council directed staff to create a contract amendment to the City's solid waste contract with Waste Management, adding a food waste recycling program for both businesses and residents. Upon City Council approval of the amendment, the food waste recycling program will begin on August 1, 2015. The City proposes to increase the solid waste service rates to reflect the cost of providing food waste recycling services to your property as shown on the attached exhibit, effective August 1, 2015.

**NOTICE IS HEREBY GIVEN that the City Council will hold a public hearing on the solid waste service rate increase on July 7, 2015, at 6:00 PM at 1400 Highland Avenue, Manhattan Beach, California in City Council Chambers.**

At the public hearing, the City Council will hear and consider all objections or protests to the proposed solid waste service rate increase. Any property owner or property tenant that is directly responsible for payment of solid waste service rates (each, a "solid waste customer") may submit a written protest against the proposed solid waste service rate increase. Written protests may be delivered to the City Clerk at the public hearing prior to the end of the public hearing or may be mailed or personally delivered to the City Clerk at City Hall, 1400 Highland Avenue, Manhattan Beach, CA 90266. Protests that are mailed or delivered to City Hall must be received by the City Clerk before 5:00 PM on July 7, 2015.

To be counted, a written protest must: (1) identify the parcel of property subject to the proposed solid waste service rate increase, (2) identify the solid waste customer and (3) include the signature of the solid waste customer. A majority protest exists if, at the end of the public hearing, there are written protests submitted by a majority of the solid waste customers subject to the proposed solid waste service rate increase. No more than one written protest per parcel of property will be counted in calculating a majority protest. The City Council cannot adopt the proposed solid waste service rate increase if a majority protest exists.

### When will the new rates go into effect? When will I see the new rates reflected in my utility bill?

If approved by City Council, the new rates (attached) will go into effect for all users on or after August 1, 2015. The new rates will be reflected in residential billings received in September 2015, which covers the July and August service period. The new rates will be reflected in the commercial billings sent on August 31.

### Can I challenge the fees in court?

Yes. You may be limited to raising only the issues you or someone else raise at the Public Hearing described in this notice, or in a written correspondence delivered to the City Clerk by the date and time above.
