- The regular meetings of the Board of Trustees are held once every two months on the second Thursday of the month (January, March, May, July, September, November) at 7:30 p.m. at the District's headquarters located at 6750 South Centinela Avenue, Culver City, CA 90230.
 - The appointed Trustee must be a resident and an elector (registered to vote) of the City from which they are appointed.
 - Trustees who attend the regularly scheduled meetings are compensated with a payment of \$100 in lieu of expenses. By law, the Trustee must attend the meeting to receive compensation. No trustee can receive more than \$100 per month for serving on the Board regardless of the number of meetings.
 - First time appointees are appointed for a two-year term. Re-appointed members may serve either a two-year or four-year term at the discretion of the City Council. There is no maximum tenure for this appointment.
- * At the May 7, 2024, City Council meeting, the City Council appointed Hilary Rosen as the next Trustee. Her term will begin January 1, 2025, and will expire on December 31, 2026.
