A. CALL TO ORDER

Chair Karger called the meeting to order at 4:00 p.m.

D. APPROVAL OF AGENDA

It was moved and seconded (Colmey/Patterson) to approve the agenda, no changes. Motion passed unanimously by roll call: 6-0 (Dickey absent).

E. APPROVAL OF MINUTES

Cultural Arts Commission Regular Meeting Minutes: November 17, 2025

It was moved and seconded (Colmey/Patterson) to approve the November minutes with one change: Pg 1, Roll Call: revise to show Commissioner Tokashiki was present in person, not remote (see top of page and in C. Roll Call). Motion passed unanimously by roll call vote: 6-0 (Dickey absent).

G. GENERAL BUSINESS

1. Cultural Arts Commission Work Plan for 2025/2026

SRS Brinkman, with input from the Commission, provided brief updates on each of the following existing Work Plan projects; all determined to be carried over into the next Work Plan

a. New Art Initiatives

- i. Public Art Brochure (Karger, Tokashiki, Dickey): brochure complete; project expanded to include one or more 50-minute art walk tours in the downtown/beach area, with the first scheduled for January 31, 2026.
 - ii. Poet Laureate (Patterson, Colmey) needs more discussion between City and LA County as to whether some aspects can be incorporated into existing library programming.
- b. Memorial for the Fallen (Tokashiki, Torrey, Karger): RFQ issued; application deadline February 23 – see online application portal: <https://www.manhattanbeach.gov/departments/parks-and-recreation/cultural-arts/memorial-for-the-fallen>.
- c. Public Art Master Plan Revision (Colmey, Rosenberg): next steps involve finalizing the formation of an APPC (Art in Public Places Committee) and schedule APPC meeting.
- d. Bruce’s Beach Public Art Commission: at City Council meeting February 17, 2026, the City Council will consider the CAC recommended proposals and approve. In November the Commission recommended a proposal by artist Toni Scott, “Unity-Circle of Memory”, subject to the artist working with the city, to research and revise the proposal to incorporate specific references relating to the Bruce family and site.

2. Cultural Arts Commission Work Plan for 2026/2027

SRS Brinkman provided a high-level overview of the Work Plan process noting that all City commission work plans are embedded within the City Council Work Plan which can be viewed on the City website at <https://www.manhattanbeach.gov/government/city-council/work-plan> – see Parks and Recreation Department section. SRS Brinkman encouraged the Commission to review online information.

SRS Brinkman has prepared a draft list of projects, as been discussed with the Chair, with input on new proposals received from commissioners and others. Staff developed a list, keeping in mind overall what is sensible or realistic in terms of resources, given what projects are already being done, and input.

SRS Brinkman read an email received from Kirstin Long Drew, Vice President of the Manhattan Beach Historical Society, describing difficulties and damages incurred to the City historical materials and requesting safe and appropriate permanent storage. To address, a new Work Plan initiative has been included.

The Commission discussed; no changes were made.

Commissioner Colmey inquired as to whether it's too late for a solution for permanent storage of historical materials to be incorporated in development options considered by the City Council as part of the downtown Project Pulse Program, discussed during last night's City Council meeting and addressing two city-owned sites: 400 Manhattan Beach Blvd (former bank) and 1155 Morningside Drive (public Parking Lot 3).

SRS Brinkman commented while he does think it is too late for such to be considered, he feels it's very important that a permanent storage site be carefully located, with appropriate physical conditions and ideally not isolated such that a lot of handling would be needed. Currently staff feels the best options is to upgrade the old Polliwog Park restrooms, relatively close to the "Red House".

SRS Brinkman clarified that historic materials storage and the Pulse project are two separate issues with different purview (historic resources under the purview of the Cultural Arts Commission and Project Pulse is under the purview of the city manager and Community Development Department. Last night the City Council directed staff to study and bring back some rough development options for both the Lot 3 and Manhattan Beach Boulevard sites based on certain narrowed categories of use with parking considerations.

SRS Brinkman concluded, advising that the proposed Cultural Arts Work Plan will be finalized by staff for presentation by Director Leyman and approval by City Council at the February 17th City Council meeting. All Commissioners are encouraged to attend that meeting; the final adopted Work Plan will be reported to the Cultural Arts Commission at its February 18th meeting.

H. STAFF ITEMS

Cultural Arts Division updates: SRS Brinkman announced:

- New classes: Ikebana workshop 1/21, 10 am to 1 pm, Live Anatomy Drawing, Thursday evenings, 1/22 through 3/26; and Intro to Photography, Sunday am, 2/8 thru 3/26.
- New MBAC exhibit “Are You Seeing What I’m Seeing?” (January 16 - end of March).

In discussing, it was suggested that cartooning classes be offered (Tokashiki) and live music be provided at the Art Center either more often during exhibit openings or, if not, perhaps independently (Patterson).

City Council updates: none

PAF budget update: Public Arts Fund has not changed: balance of \$1.6 million, \$1.1 million allocated and \$580 thousand unallocated with no expiration until end of 2027.

I. COMMISSION ITEMS

Chair Karger reviewed preparations for the January 31 downtown art walk tour. There are 50 reservations, 20 wait-listed; meet at Joslyn before 4:00 pm. An updated script (12/10/25) and PowerPoint has been sent to commissioners. Commissioners can pick up guide t-shirts at Parks and Recreation from SRS Brinkman; Commissioner Colmey will bring 10 tour flags matching the tees, perhaps stagger in groups by 5 minutes, will play by ear.

Commissioner Patterson inquired, Commissioner Rosenberg clarified proposed Work Plan proposal for a film festival – that it would be a traditional film festival for viewing films, with involvement of Mira Costa students. It was noted that at last night’s City Council meeting, City Council adopted a city filming policy (Ordinance) and students will be exempted from Film LA fees.

J. ADJOURNMENT

At 4:59 pm it was moved and seconded (Torrey/Tokashiki) to adjourn the meeting to February 18; approved unanimously.
