# AMENDMENT NO. 6 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND GRANICUS, LLC.

This Sixth Amendment ("Amendment No. 6") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Granicus, LLC, a Minnesota limited liability company ("Contractor") (collectively, the "Parties") is hereby entered into as of January 1, 2026 ("Effective Date").

#### RECITALS

- A. On February 1, 2018, the City and Contractor entered into an agreement for professional services for the Contractor to provide streaming media solutions that include hardware, software, automated indexing capabilities, voting systems, website page design, and integration with City Council agenda, meeting minutes module, and related support services ("Original Agreement").
- On February 1, 2019, the City and Contractor entered into B. Amendment No. 1 ("Amendment No. 1") to extend the term, increase the maximum compensation to be paid to the Contractor (the "Maximum Compensation"), and modify the services to be performed by the Contractor (the "Services"). On January 1, 202, the City and Contractor entered into Amendment No. 2 ("Amendment No. 2") to extend the term, increase the Maximum Compensation, clarify the Parties' rights to certain information and documents, update the City's contact information, and modify the Services. On January 1, 2021, the City and Contractor entered into Amendment No. 3 ("Amendment No. 3") to extend the term, increase the Maximum Compensation, and modify the Scope of Services and Payment Schedule. On January 1, 2023, the City and Contractor entered into Amendment No. 4 ("Amendment No. 4") to extend the term, increase the Maximum Compensation, and modify the Scope of Services and Payment Schedule. On January 1, 2024, the City and Contractor entered into Amendment No. 5 ("Amendment No. 5") to extend the term, increase the Maximum Compensation, and modify the Scope of Services and Payment Schedule.
- C. The Original Agreement, as amended by Amendment No. 1, No. 2, No. 3, No. 4, and No. 5, is hereinafter referred to as the "Agreement."
- D. The Parties now desire to amend the Agreement to increase the Maximum Compensation and modify the Scope of Services and Payment Schedule.
- NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:
- <u>Section 1.</u> Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$21,428.64, for a new Maximum Compensation of \$1,120,716.73.

<u>Section 2.</u> Exhibit A of the Agreement is hereby amended and restated by the Exhibit A Scope of Services and Payment Schedule attached to this Amendment.

<u>Section 3.</u> Except as specifically amended by this Amendment No. 6, all other provisions of the Agreement as previously amended by Amendment Nos. 1, 2, 3, 4, and 5 shall remain in full force and effect.

## C. Amendment No. 4, Exhibit A, Section B Additional Services

Additional Services amounts included in Section B of Amendment No. 4, Exhibit A Scope of Services and Payment Schedule that have not been finalized are to remain due and to be completed at the City's discretion. The payment schedule for the remaining services is amended as follows:

- Website Redesign (simple) / City Website <u>www.manhattanbeach.gov</u> – it may include Content Management System (CMS), rebranding, etc.
  - Project Billing Schedule
- An initial payment equal to 40% of the total upon Granicus' delivery of the URL to the development website;
- A payment equal to 20% of the total upon Granicus's delivery of the draft homepage design concepts to the client;
- A payment equal to 20% of the total upon implementation of the main website into the VCMS on a Granicus-hosted development server; and

- A payment equal to 20% of the total upon completion; provided, however, that the client has completed training. If the client has not completed training, then Granicus shall invoice the client at the earliest of completion of training or 21 days after completion.
- Meeting System Changes / Legistar Agenda and Legislative
   Management System Meeting system updates, corrections/changes handled via configuration changes and/or software, and other related services.

### D. Other Services and Payment Schedule

The services listed are additional and related to the City website <a href="https://www.manhattanbeach.gov">www.manhattanbeach.gov</a> and/or updates to the meeting management platform. They are to be initiated and scheduled for implementation per the City's discretion. The service costs are one-time but are to be adjusted and prorated as of the City's acceptance date and for actual services rendered after City approval. Amounts may be split if the services are spread between two fiscal years. The City will notify the contractor in writing if there are any modifications to the payment schedule once the services are implemented/completed.

1. Meeting System Changes / Legistar Agenda Management System Single Sign-on – Implementation services for Legistar Active Directory Pass-through Authentication

Estimated Cost (prepaid after City initiates services): \$2,500

2. Optional Ad-Hoc Granicus Professional Services / City website <a href="https://www.manhattanbeach.gov">www.manhattanbeach.gov</a> or GovMeeting (Legistar) platforms – it may include small changes related to branding, homepage wireframe/design and interior pages layout, Legistar configuration, Media Manager, etc.
