C. CERTIFICATION OF MEETING NOTICE AND AGENDA POSTING

City Clerk Liza Tamura confirmed that the meeting was properly posted.

E. GENERAL BUSINESS

1. Presentation of Urban Land Institute's Advisory Services (City Manager Danaj).

ACCEPT PRESENTATION AND PROVIDE DIRECTION IF APPLICABLE

City Manager Mark Danaj gave a brief presentation on the Urban Land Institute (ULI) stating that it is an advisory service panel used to kick-start conversations around land use. The goal tonight is to learn how it works, how it helped other communities, and whether or not it is a useful tool for options for downtown Manhattan Beach.

City Manager Danaj then introduced Tom Eitler, Vice President for Advisory Services from the Urban Land Institute (ULI) who explained that ULI is a non-profit education research organization, that is world-wide and gave a PowerPoint Presentation.

City Manager Danaj and Mr. Eitler answered City Council questions.

Mayor Powell opened the floor to public comment.

Jim O' Callaghan, Chamber of Commerce, explained that the City needs to address public and professional perception.

Patrick McBride stated his opinion that bringing in experts is something he has always wanted.

Gerry O'Connor asked if City Council were to decide on ULI, would there be a Request for Proposal (RFP) or would this process be called a "Specialty Service".

Bill Victor commented that "Focus Groups" might be something to consider.

Seeing no further requests to speak, Mayor Powell closed the public comment.

Discussion continued among City Councilmembers about the visioning process and including the residents.

A motion was made by Mayor Pro Tem Burton, seconded by Councilmember Howorth, to enter into negotiations to bring Urban Land Institute (ULI) to the City.
