

RESOLUTION NO. 25-0116

A RESOLUTION OF THE CITY COUNCIL OF MANHATTAN BEACH CITY, CALIFORNIA, AMENDING THE CITY'S USER FEE SCHEDULE TO UPDATE EMERGENCY MEDICAL SERVICES (EMS) RATES, INCLUDING BASE TRANSPORT, NIGHT CHARGE, OXYGEN CHARGE AND DISPOSABLE MEDICAL SUPPLIES AND ADOPT BILLING PRACTICES CONSISTENT WITH ASSEMBLY BILL (AB) 716

WHEREAS. The City of Manhattan Beach participates in the Los Angeles County Emergency Medical Services (EMS) system and charges for ambulance transport in accordance with County established rates; and

WHEREAS. The City Council adopts and amends the Citywide User Fee Schedule periodically to ensure compliance with State law and transparency in cost recovery; and

WHEREAS. On January 1, 2024, Assembly Bill 716 (AB 716) became effective, prohibiting the bundling of related ambulance charges with unrelated services and requiring itemized billing; and

WHEREAS. To comply with AB 716, the City must separately identify allowable ambulance service charges, including base transport rates, night charges, oxygen and disposable medical supply usage, consistent with Los Angeles County EMS standards.

THE MANHATTAN BEACH CITY COUNCIL HEREBY RESOLVES AS FOLLOWS:

SECTION 1. The City's User Fee Schedule is amended to update Emergency Medical Services (EMS) section set forth on Exhibit A.

SECTION 2. This resolution shall take effect immediately upon adoption and the amended EMS fee schedule shall be incorporated into the published Citywide User Fee Schedule.

SECTION 3. The EMS fees will adjust in accordance with the Los Angeles County Emergency Medical Services Agency General Public Ambulance Rates.
