AMENDMENT No. 3 TO MEASURE M FUNDING AGREEMENT BETWEEN CITY OF MANHATTAN BEACH AND THE LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY

This Amendment No. 3 to the Funding Agreement (this "Amendment"), is dated as of February 15, 2024 by and between the City of Manhattan Beach ("GRANTEE") and the Los Angeles County Metropolitan Transportation Authority ("LACMTA").

RECITALS:

- A. GRANTEE and LACMTA entered into that certain Funding Agreement No. 920000000M550804, dated February 15, 2020, which was amended on February 1, 2022 and September 30, 2023 (as amended, the "Existing FA"), which Existing FA provides for the Advanced Traffic Signal System, ("the Project"); and
- B. WHEREAS, the LACMTA Board on September 28, 2023 approved the additional Measure M Funds of \$4,963,000 from \$12,750,000 to \$17,713,000 for Plans, Specifications and Estimates (PS&E), and Construction. This amount is within the Board authorized budget increase for the Project; and
- C. WHEREAS, the Funds are currently programmed as follows: \$1,100,000 in FY 2019-20, \$2,540,000 in FY 2020-21, \$1,800,000 in FY 2021-22, \$5,310,000 in FY 2022-23, \$3,000,000 in FY 2023-24 and \$3,963,000 in FY 2024-25. The total designated for Plans, Specifications and Estimates (PS&E), and Construction of the Advanced Traffic Signal System is \$17,713,000; and
- D. WHEREAS, the LACMTA Board on September 23, 2021, delegated administrative authority to staff to extend the funding lapsing date of the Measure M Funds previously approved to meet environmental, design, right-of-way, and construction time frames; and
- E. WHEREAS, the GRANTEE and LACMTA desire to extend the lapse date of FY 2020-21, and 2021-22 funds to June 30, 2025; and
- F. GRANTEE and LACMTA desire to amend the Existing FA as provided herein.

AGREEMENT:

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

- 1. Part I, Paragraph 2.2 of the Existing FA is hereby amended by deleting it in its entirety and replacing it with the following: "To the extent the Measure M funds are available, LACMTA shall make to GRANTEE a grant of the Measure M funds in the amount of \$17,713,000 (the "Funds") for the Project. LACMTA Board of Directors' actions on September 26, 2019, September 23, 2021, and September 28, 2023, approved Measure M Funds for the Project. The Funds are currently programmed over six Fiscal Years: \$1,100,000 in FY 2019-20; \$2,540,000 in FY 2020-21; \$1,800,000 in FY 2021-22; \$5,310,000 in FY 2022-23; \$3,000,000 in FY 2023-24, and \$3,963,000 in FY 2024-25."
- 2. Part II, Section 9.1 (vi) of the Existing FA is hereby amended by deleting it in its entirety and replacing it with the following: "(vi) Expending the Funds granted under this FA for allowable costs by the lapsing date. All Funds programmed for FY 2019-20 have been expended and are no longer available. All Funds programmed for FY 2020-21, FY 2021-22, and FY 2022-23 are subject to lapse by June 30, 2025. All Funds programmed for FY 2023-24 are subject to lapse by June 30, 2026. All Funds programmed for FY 2024-25 are subject to lapse by June 30, 2027."
- 3. Attachment A-1 of the Existing FA is hereby replaced by Attachment A-2, attached.
- 4. Attachment B-1 of the Existing FA is hereby replaced by Attachment B-2, attached.
- 5. Attachment C of the Existing FA is hereby amended by deleting the Project Schedule and replacing it with the following Revised Project Schedule.
