RESOLUTION NO. 25-0094

A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL APPROVING A REPORT IN CONNECTION WITH THE CITY'S STORM DRAIN SERVICE CHARGE AND ORDERING THAT SUCH CHARGE BE COLLECTED ON THE TAX ROLL

THE MANHATTAN BEACH CITY COUNCIL HEREBY FINDS, DETERMINES, ORDERS, AND RESOLVES AS FOLLOWS:

SECTION 1. Recitals

A. The City levies an annual storm drain service charge (the "Charge") on each parcel of real property in the City. The Charge is levied to finance the costs of on-going operation and maintenance of storm drain facilities and services ("Storm Drain Services").

B. As authorized by California Health and Safety Code Section 5473, the Charge is collected for each fiscal year on the County of Los Angeles tax roll in the same manner, by the same persons, and at the same time as, together with and not separately from, the general taxes of the City.

C. A written report (the "Report") has been filed with the City Clerk, containing a description of each parcel of real property receiving Storm Drain Services and the amount of the Charge for each parcel for Fiscal Year 2025-2026 (commencing July 1, 2025, and ending June 30, 2026). The Report is on file in the office of the City Clerk and incorporated herein by reference.

D. The City Clerk caused notice of a hearing on the Report to be published in The Beach Reporter July 3, 2025, and July 10, 2025.

E. The City Council held a public hearing on the Report on July 15, 2025. At the hearing, the City Council heard and considered all objections and protests, if any, to the Report and all testimony regarding the proposed levy of the Charge for Fiscal Year 2025-2026.

<u>SECTION 2</u>. The City Council hereby overrules any and all objections to the Report; determines that no majority protest against the Report, determined in accordance with Health and Safety Code Section 5473.2, exists; approves and adopts the final Report as filed, including any amendments; determines that the Charge for Fiscal Year 2025-2026 against each parcel described in the Report shall be as described in the Report; approves the Consumer Price Index (CPI) adjustment of 3.4%; and orders that the Charge shall be collected for Fiscal Year 2025-2026 on the County of Los Angeles tax roll in the same manner, by the same

persons, and at the same time as, together with and not separately from, the general taxes of the City.

<u>SECTION 3</u>. The City Clerk is directed to file a copy of the Report, with a statement endorsed on the Report over the City Clerk's signature that the Report has been approved and finally adopted, with the County Auditor of the County of Los Angeles on or before August 10, 2025.

<u>SECTION 4</u>. The City Clerk is authorized to take such other action as is required to implement this Resolution.
