

AMENDMENT NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF MANHATTAN BEACH AND THE LAW OFFICES OF
ANGEL HO, INC.

This Amendment No. 2 ("Amendment No. 2") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and the Law Offices of Angel Ho, Inc., a California corporation ("Consultant") (collectively, the "Parties") is hereby entered into as of June 1, 2025 ("Effective Date").

RECITALS

A. On February 1, 2024, the City and Consultant entered into an agreement for professional services for the Consultant to provide administrative investigation services on an "as-needed" basis ("Original Agreement").

B. On May 1, 2024, the City and Consultant entered into Amendment No. 1 ("Amendment No. 1") to increase the Maximum Compensation.

C. The Original Agreement as amended by Amendment No. 1 is hereinafter referred to as the "Agreement."

D. The Parties now desire to amend the Agreement to increase the Maximum Compensation.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

Section 1. Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$50,000, for a new Maximum Compensation of \$300,000.

Section 2. Except as specifically amended by this Amendment No. 2, all other provisions of the Agreement shall remain in full force and effect.
