Mr. Masters,

apologies for the late submittal of comments. I live at 201 Kelp Street, almost directly behind 130 41st Street. I do not support the approval of the appeal request. For several weeks, I noticed the sound of either a "running shower" or open water faucet coming from a location near my house. All the houses in these blocks are very close and any sound echoes and reverberates across the block. I had assumed it was either a surfer rinsing off after a day at the beach or some sort of open faucet or plumbing leak. It was odd to hear the sound at different hours of day and night. After discussing this several times with my neighbors, it was brought to my attention that the source of the sound was coming from the house almost directly behind mine located at 130 41st street.

I do not judge the owner's decision to have a fountain in their house, but I think the decision did not consider the impact to other in the sorrounding houses. If you live in this area, you know that hearing the sound of the ocean is one of the major attributes. The noise created by the fountain is a distraction and it stands out more as a problem than an attribute. Frankly, it does not add to the location and more times than not it creates the impression that the noise is caused by a faucet or shower left unattended.

If I cound not hear the running water from the water fountain, I would not comment on this. But I, and others near 130 41st do. I prefer not to. We were not and have not been consulted on the matter. I'd appreciate if the request and appeal are not approved so the water fountain is not in use at any hour of the day.

Dear PPIC,

I urge you to deny the water feature encroachment at 130 41st Street.

There is no justification for allowing this unpermitted and illegally constructed encroachment onto City land and the Public right-of-way.

The City cannot maintain a policy of granting exemptions for illegal encroachments simply because they have already been constructed. The idea that it is easier to ask for forgiveness rather than asking for permission, and justifying the encroachments because they were expensive to build; or because they are "pretty," or because a couple of neighbors send letters saying that the encroachment is ok by them, is not a workable policy for our town. Further, old existing construction and encroachments, that do not meet current code, cannot justify additional non-conforming encroachments.

Please remember that every exemption that is granted becomes precedent, for a mile around, to allow even more exemptions.

The City is currently reviewing its Mobility Plan. Among many concerns is the ever-increasing encroachment onto the public right-of way for yards, fences, landscaping, etc. This pushes pedestrians into the streets, which in turn impacts vehicular traffic and public safety.
