Proposition 218 process approves solid waste rate increases for only five years

PROPOSITION 218 PROCESS

What is Proposition 218?

- Passed by CA voters in 1996.
- Proscribe ("limits") methods local governments can create or increase taxes/fees/charges.
- Allows property owners or rate payers to protest utility rate increases.
- Mandatory 45-day protest period.
- Public Hearing & absence of a majority protest required prior to Council adoption of new rates.
 - Public Hearing date is May 20, 2025.



PROPOSITION 218 PROCESS

What Notification is Required

- ✓ Publish Beach Reporter print ads on 3/27, 4/3, 4/10, 4/17 and Public Hearing Notice on 5/1.
- ✓ Publish Beach Reporter In-Story ad from March 28 – May 19.
- ✓ Host Hybrid Community Meeting on 4/3/25 in CC Chambers, 6pm.
- ✓ Upload recorded meeting to Prop 218 page on City website.

Protests must be received between March 28, 2025 – May 20, 2025, and prior to the close of the public hearing.



IF PROTEST IS SUCCESSFUL

What Happens if the City Receives Enough Protests to Overturn the Rate Increase?

Majority Protest = need 50% + 1 protests. With just over 13,000 parcels, the City would need to receive at least 6,500 protests.

- The City Council cannot approve the customer rate increase if there is a "majority protest."
- A majority protest exists if the City Clerk must receive written protests from 50% + 1 of the property owners/rate payers in Manhattan Beach to prevent the rate increase from taking effect.



IF PROTEST IS SUCCESSFUL CONT'D

City Council Options if Protest is Successful

- 1. The City will then pay the increase from the General Fund for the term of the contract.
- 2. City Council can amend its contract with Waste Management, to <u>reduce services</u> to lower the contract rate.
- 3. City Council can also initiate the Proposition 218 process again.

- Eligible for properties with 2 9 units
- Cannot have any commercial bins

STAFF RECOMMENDED ACTION

- Adopt Resolution No. 25-0021 setting May 20, 2025 for a Proposition 218 public hearing under the Proposition 218 protest procedure to consider adopting new residential and commercial solid waste hauling fees and City Recovery Costs, inclusive of annual Consumer Price Index (CPI) escalations over the next five fiscal years; and
- Adopt Resolution No. 25-0022 adopting procedures in connection with the proposed solid waste hauling fee increases.
