

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT  
BETWEEN THE CITY OF MANHATTAN BEACH AND BEACH CITIES HEALTH  
DISTRICT

This First Amendment ("Amendment No. 1") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Beach Cities Health District, a public health government agency formed under California's Local Health Care District law ("Contractor") (collectively, the "Parties") is hereby entered into as of July 1, 2021 ("Effective Date").

RECITALS

A. On July 1, 2020, the City and Contractor entered into an agreement for professional services for the Contractor to provide a Juvenile Diversion Project ("JDP") for the residents of Manhattan Beach and students of the Manhattan Beach Unified School District ("Agreement"). The JDP is an intervention process that addresses offenses committed by young offenders up to the age of 23, directing them away from involvement with the criminal courts. The objectives are to hold youth fully accountable and prevent recidivism without the stigma and far reaching entanglements that accompany entry into the criminal justice system.

B. The Parties now desire to amend the Agreement to extend the term to June 30, 2024.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

Section 1. Section 2 of the Agreement is hereby revised to extend the term of the Agreement through June 30, 2024, unless sooner terminated as provided in Section 12 of the Agreement.

Section 2. Section 3.A of the Agreement is hereby revised to increase the Maximum Compensation amount by \$100,000, for a new Maximum Compensation of \$150,000.

Section 3. Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.
