## DONATION AGREEMENT

THIS DONATION AGREEMENT ("Agreement") is made and entered into on this \_\_\_\_\_\_ day of March, 2025 ("Effective Date"), by and between the City of Manhattan Beach, a California municipal corporation ("City") and Rio Hondo Community College District, a California community college district ("Rio Hondo"). City and Rio Hondo are sometimes referred to herein as the "Parties", and individually as a "Party".

## RECITALS

A. City's Fire Department has received a request for surplus equipment from the Rio Hondo College Fire Academy, attached as **Exhibit A**.

B. The City wishes to encourage its relationship with Rio Hondo and encourage the welfare of the students within the community by providing the surplus equipment to Rio Hondo.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the City and the Rio Hondo hereby covenant, represent and agree as follows:

1. City shall convey to Rio Hondo all equipment listed in **Exhibit B** (hereinafter the "Equipment"). Transfer of ownership of the Equipment shall be deemed to have taken place upon execution of this Agreement and transfer of necessary ownership documents.

2. The Equipment shall be conveyed to Rio Hondo with no warranty, express or implied. City expressly disclaims any warranties of fitness for purpose and merchantability. City makes no representation that the Equipment can be used in any capacity. Rio Hondo shall accept the Equipment in "AS IS" condition. Rio Hondo releases City from any and all claims of defect of the Equipment. Rio Hondo expressly waives any and all rights under Section 1542 of the Civil Code of the State of California, or any other federal or state statutory rights or rules, or principles of common law or equity, or those of any jurisdiction, government, or political subdivision, similar to Section 1542 ("Similar Provision"). Rio Hondo may not invoke the benefits of Section 1542 or any Similar Provision in order to prosecute or assert in any manner any claims released. Section 1542 provides as follows:

"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release, and that if known by him or her would have materially affected his or her settlement with the debtor or released party."

3. Rio Hondo shall defend, indemnify, and hold harmless the City, its officials, and every officer, employee and agent of City (collectively "Indemnitees") from any claim, liability or financial loss (including, without limitation, attorneys' fees and costs), injuries to property or persons (including without limitation, attorneys fees' and costs) arising out

of any acts or omissions of Rio Hondo, its officials, officers, employees, students or agents in connection with this Agreement, except for such claim, liability or financial loss or damage arising from the sole negligence or willful misconduct of the Indemnitees, as determined by court decision or by the agreement of the Parties. Rio Hondo shall defend the Indemnitees, at Rio Hondo's own cost, expense, and risk, and shall pay and satisfy any judgment, award, or decree that may be rendered against the Indemnitees. Rio Hondo shall reimburse the Indemnitees for any and all legal expenses and costs incurred by each of them in connection therewith or in enforcing the indemnity herein provided. Rio Hondo's obligation to indemnify shall not be restricted to insurance proceeds, if any, received by Rio Hondo or the Indemnitees. All duties of Rio Hondo under this Section shall survive termination of this Agreement.

4. Rio Hondo shall make and pay for all necessary arrangements for the transportation of the Equipment to its facilities. The arrangements shall include the payment of all taxes, fees or charges and the procurement of all necessary insurance, licenses and permits required in connection with removal of the Equipment from City property and transfer to Rio Hondo.

5. This Agreement shall be interpreted in accordance with the laws of the State of California, and the City of Manhattan Beach, without regard to conflict of law principles. In any action arising out of this Agreement, Rio Hondo consents to personal jurisdiction, and agrees to bring all such actions, exclusively in state or federal courts located in Los Angeles County, California.

6. If a Party commences any legal, administrative, or other action against the other Party arising out of or in connection with this Agreement, the prevailing Party in such action shall be entitled to have and recover from the losing Party all of its attorneys' fees and other costs incurred in connection therewith, in addition to such other relief as may be sought and awarded.

7. City shall not be obligated or liable under this Agreement to any party other than Rio Hondo.

8. If any part, term or provision of this Agreement is held void, illegal, unenforceable, or in conflict with any law of a federal, state or local government having jurisdiction over this Agreement, the validity of the remaining parts, terms or provisions of the Agreement shall not be affected thereby.
