

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF MANHATTAN BEACH AND WESTMED
AMBULANCE, INC., DBA MCCORMICK AMBULANCE

This First Amendment ("Amendment No. 1") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Westmed Ambulance, Inc., a California corporation dba McCormick Ambulance ("Contractor") (collectively, the "Parties") is hereby entered into as of September 20, 2022 ("Effective Date").

RECITALS

A. On March 20, 2020, the City and Contractor entered into an agreement for professional services for the Contractor to provide emergency ambulance transport services ("Agreement").

B. The Parties now desire to amend the Agreement to remove the maximum compensation amount in lieu of continuing to utilize the agreed upon per transport cost.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

Section 1. Section 6 of the Agreement is hereby amended to read as follows:

"A. In consideration of the services rendered hereunder, City shall pay Contractor a fee in accordance with the prices in the following schedule:

Year 1 (3/19/20-3/18/21) \$380 per transport
Year 2 (3/19/21-3/18/22) \$389 per transport
Year 3 (3/19/22-3/18/23) \$398 per transport

B. If one or both of the option periods are exercised, the amount per transport shall be as follows:

First Option Year (if exercised) (3/19/23-3/18/24) \$407 per transport
Second Option Year (if exercised) (3/19/24-3/18/25) \$417 per transport

C. The prices set forth in this Section include all costs and expenses; City will not reimburse Contractor for any expenses incurred in the performance of the Services."

Section 2. Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.
