

AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF MANHATTAN BEACH AND DIXON RESOURCES
UNLIMITED

This First Amendment ("Amendment No. 1") to that certain agreement is by and between the City of Manhattan Beach, a California municipal corporation ("City"), and Dixon Resources Unlimited, a California corporation ("Consultant") (collectively, the "Parties"). The date the City Council approves this Amendment shall be the date this Amendment is effective ("Effective Date").

RECITALS

A. On March 13, 2025, the City and Consultant entered into an agreement for professional services for the Consultant to provide specialized consulting services related to municipal parking operation services ("Original Agreement").

B. The Parties now desire to amend the Agreement to increase the Maximum Compensation.

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

Section 1. Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$151,000, for a new Maximum Compensation of \$225,900.

Section 2. Exhibit A, Scope of Services of the Agreement, is hereby supplemented by Exhibit A-1, Scope of Work attached to this Amendment.

Section 3. Exhibit B, Approved Fee Schedule of the Agreement, is hereby supplemented by Exhibit B-1, Approved Fee Schedule to this Amendment

Section 4. Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.

EXHIBIT A-1 SCOPE OF SERVICES

Consultant will provide ongoing and additional consulting and project management support based on specific direction from the City's Public Works Director or his designee. Additional services may include, but are not limited to:

- Municipal code review
- Procurement Support (Pay station, Mobile, LPR, PGS)
- Implementation support
- Signage Assessment
- Dixon Data Suite data collection and analysis tool

APPROVED FEE SCHEDULE

Consultant's fee schedule is amended to include the additional following classifications:

CLASSIFICATION	RATE PER HOUR
Principal-in-Charge	\$255
Junior Associate	\$125

*The pricing set forth herein shall remain in effect through June 30, 2026. Thereafter, Consultant may submit a proposed billing rate adjustment not to exceed a 3% Consumer Price Index (CPI) increase, for review and written approval by the City's Director of Public Works or his designee, at the City's sole discretion. Consultant shall provide the City with written notice of any proposed rate increase at least thirty (30) days prior to the intended effective date.
