- 2. <u>COMPENSATION AND METHOD OF PAYMENT</u> is amended to reflect the following: One Hundred Ninety-Nine Thousand Nine Hundred Seventy-Two Dollars and Zero Cents (\$199,972.00). This is an increase of Eighty-Six Thousand Two Hundred Dollars and Zero Cents (\$86,200.00) to the project amount.
- 3. <u>BUDGET SECTION</u> is amended to reflect the new compensation of One Hundred Ninety-Nine Thousand Nine Hundred Seventy-Two Dollars and Zero Cents (\$199,972.00). The budget is amended to reflect the new Uncategorized increase of Eighty-Six Thousand Two Hundred Dollars and Zero Cents (\$86,200.00).

This Amendment Number 1 amends the Agreement to Implement to reflect the additions and/or change(s) noted above, and this section(s) should be substituted in its entirety or added to the Agreement to Implement. All other terms and conditions of said Agreement to Implement shall remain the same.
