AMENDMENT NO. 3 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND QUICK CAPTION INC.

This Third Amendment ("Amendment No. 3") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Quick Caption, Inc., a California corporation, ("Contractor") (collectively, the "Parties") is hereby entered into as of July 19, 2022 ("Effective Date").

RECITALS

- A. On August 1, 2017, the City and Contractor entered into an agreement for professional services for the Contractor to provide broadcast real-time closed captioning services ("Agreement").
- B. On May 21, 2019, the City and Contractor entered into Amendment No. 1 to increase the annual maximum compensation amount of Section 3.A and to revise the terms of the additional services in Section 3.C.
- C. On August 1, 2020, the City and Contracted entered into Amendment No. 2 to extend the term of the Agreement through August 1, 2022.
- D. The Parties now desire to amend the Agreement to extend the term and update the fee schedule.
- NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:
- <u>Section 1.</u> Section 2 of the Agreement is hereby amended to extend the term of the Agreement through July 31, 2023, unless sooner terminated as provided in Section 12 of the Agreement.
- <u>Section 2.</u> Exhibit B (Approved Fee Schedule) of the Agreement is hereby replaced with Exhibit A of this Amendment No. 3 to update the fee schedule.
- <u>Section 3.</u> Except as specifically amended by this Amendment No. 3, all other provisions of the Agreement (as previously amended by Amendment Nos. 1 and 2) shall remain in full force and effect.
