

# **HOMELESS COUNT REGIONALLY**







## **HOMELESS CENSUS**

- SBCCOG was exploring contracting with the City of Redondo Beach's contractor, CityNet, to provide a regional homeless count that provides accurate and detailed data on the homeless population.
- Staff approached CityNet and received a proposal for \$24,402 to conduct a homeless census survey solely for Manhattan Beach.

### BEACH CITIES GRAND FUNDED CONTRACT

- City of Manhattan Beach has served as a contract administrator for two Measure H grants totaling \$546,000.
- SBCCOG and staff have agreed to transition this ongoing responsibility to ensure the contract is managed by a regional entity since it is a regional contract.

#### SHARE! HOUSING TRANSITION TO SBCCOG

- Smooth transition to SBCCOG services.
- SBCCOG, has funded interim housing for 15 new individuals since September 2023.
  - Amounted to approximately \$35,700 in cost savings to the City.
- Flexibility with housing more than the allotted five individuals, thereby increasing the City's housing capacity.


### **DEDICATED OUTREACH CONTRACT RFP**

- Harbor Interfaith Services Agreement expires on December 1, 2024
- RFP Process began on August 8
- City Council approval for a homeless outreach service provider in November 2024.

# **FUTURE OF MEASURE H**

- Los Angeles County voters approved a countywide ballot measure on the March 7, 2017, ballot which imposed a 10-year, ¼ cent sales tax to help fund housing and support services for the homeless population throughout the County.
- Measure A on November 5, 2024, Election Ballot
  - Repeals the 2017 Measure H tax
  - ° Replacing it with a 1/2 cent sales tax, raising approximately \$1,076,076,350



## **FUTURE OF MEASURE H**

#### Important provisions:

- Currently, Measure H is scheduled to expire in March 2027. Measure H 2.0 does not have a sunset clause and can only be repealed by the voters.
- 2. Measure H 2.0 does not impact the sales tax limit imposed by the State.
- 3. Measure H 2.0 does not have a direct allocation for cities to cover costs of homeless services.

# FUNCTIONAL ZERO STREET HOMELESSNESS COMMENDATION PROGRAM



Achieving Functional Zero Street
Homelessness requires the number of
people exiting street homelessness to be
greater than the number of people
entering street homelessness, and the
median duration of the current street
population is less than 90 days.

#### Street Outflow > Street Inflow

Functional Zero is a recognition that homelessness can occur at any time, but when someone does experience homelessness, the experience is brief and one time.





South Bay Cities Council of Governments' (SBCCOG's) Functional Zero Street Homelessness Commendation Program will track, monitor, and report on a City's progress towards Functional Zero Street Homelessness.

SBCCOG will work collaboratively with enrolled cities and their homelessness teams to create tactical game plans that suit each individual city's needs.

SBCCOG will monitor a city's monthly performance in 6 month intervals. The City's Outreach and Case Management Teams will send an assigned SBCCOG Data Analyst weekly reports on inflow and outflow. Additionally, the Teams will meet in person once a month with SBCCOG staff to case conference.

- SBCCOG will report to cities at regular monthly intervals.
- In addition to reporting Inflow, Outflow, and Duration, SBCCOG will also present demographic and psychographic data.
- Based on this data, cities can evaluate appropriate next steps to get closer to Functional Zero Street Homelessness



When a city has achieved Functional Zero Street Homelessness for a minimum of 6 months, the city will have graduated from the Commendation Program!

- The SBCCOG intends to have an annual ceremony to celebrate city cohorts who have graduated from the program.
- Sustainability: SBCCOG will continue to work with Graduated cities that Functional Zero Street Homelessness is maintained.





- Redondo Beach has been our first pilot city
  - Expected to announce results in the summer 2024
- Currently seeking our next cohort of cities
- City of Manhattan Beach is a good candidate for this program with its low homeless count, homeless staff, neighborhood activism (MB Safe), and access to regional resources such as SHARE!

APPENDIX.

**Inflow (A)** can be any person entering homelessness due to factors including but not limited to...

- Those losing their home due to eviction or family dynamics
- Those fleeing housing due to domestic violence
- Those on fixed income unable to afford housing
- Housing instability due to physical or behavioral health disabilities



Outflow (B) can be any person exiting homelessness due to factors including but not limited to ...

- Obtaining permanent housing with the assistance of programs (LAHSA, Harbor Interfaith, PATH)
- Obtaining housing through family reunification or relocation through SBCCOG Client Aid
- Obtaining an interim housing placement\*
- Access to motels or shared housing

<sup>\*</sup> The SBCCOG Functional Zero Street Homelessness definition of outflow includes interim solutions as the goal is to eliminate street homelessness



C = Current unhoused, unsheltered population

Gap(G) = Street Population [C + Inflow(A)] - Outflow(B)


The SBCCOG's Functional Zero Program will help cities solve for (G).

- For (G), the Program will collaborate with cities to bring additional system supports to house/shelter average monthly inflow that exceed the city's outflow capacity. Sustainable solutions may include shared beds, supportive housing, motel bed rentals, safe parking spaces, and other transitional beds.
- For (C), the Program will work with the city and case managers to develop a housing plan for each of the city's current population. An estimated 1/3 of this population will require additional supports, such as ongoing recuperative care or supportive senior housing. Together, we will leverage County and State programs to provide a higher level of care for our higher acuity populations.



Solving for the Gap (G) not only means increasing Outflow (B), but also reducing Inflow (A)

- Together with Cities, we will utilize SBCCOG Client Aid and County Prevention programs to curtail inflow
- We will also collaborate with thought partners at UCLA on how to identify constituents at risk of homelessness, and develop intervention strategies

#### **Monthly Average**

Gap(G) = Street Population(C + Inflow(A)) - Outflow(B)

- A= 12
- B= 20
- C= 56 (current existing population)
- G= 48
  - 16 assumed high acuity

Tactical plan to bridge 48 person Gap:

- 20 Additional Pallet Shelter Beds
- 13 Additional SRO Beds
- 5 SHARE! Beds
- 4 Permanent Supportive Housing referral slots (more with Project Homekey: Moonstone)
- 3 DMH Housing referrals
- 2 Motel Beds
- 1 Safe Parking Referral
