Jim and Marisa::

I was reading the staff report yesterday when it became available and realized the situation is much worse than you state . I have an appointment to speak with the Coastal Commission staff on Monday concerning what you have pointed out but also that Ocean Drive has been made a bicycle route despite the fact that (1)Manhattan Ave is already one and (2) the bike path is also dedicated to the safety of bikers and pedestrians on each side of Ocean Drive. The route of the bike path on Ocean Drive has been advocated strongly by the Southbay Bicycle Coalition and I suggest that we contact them as I plan to Monday to ask them to please consider the plan to reroute the bike path onto the Bike path where I personally believe it belongs.

I will also send you all a list of four of its officers with methods to contact them. One of the important officers is in the DRG and by email now to Todd D. I ask that he make an effort to assist in this before it gets continued as an accident waiting to happen even before the valet at Ocean Drive is set up.

There is a very nice feature article in the Easy Reader this week which also includes many of the wonderful projects this organization is involved in but I personally think that Ocean Drive bike route is not the best of the ideas in view of garages and parking spaces backing into Ocean Drive from the east and the west, the stop signs which are ignored by many bikers at crossings of pedestrians going to the beach such as at ninth street, the tremendous flow of taxis and other valet driven vehicles during the valet parking rush traffic and dangers to pedestrians, bikers, residents, automobile occupants and shoppers alike. I personally have nine parking spaces which back into Ocean Drive which will not become more dangerous for tenants to use..

One of the reasons given to make Ocean Drive a bike route is that our MB City traffic engineer, Erik V. explains that there are not enough exits for persons who want to go downtown from the official bike path. He was not aware of some of them such as seventh street, but anyway I suggested that more exits from the bike path be included in the plans including the DDSP and I am copying Marisa L.of the Community Development Department with this email who was out of the office on Thursday and Friday when I tried. She and I may be able to speak on Monday according to a message I received from her before she left..
