## AMENDMENT NO. 5 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND SA ASSOCIATES FOR PROJECT MANAGEMENT CONSULTANT SERVICES

This Fifth Amendment ("Amendment No. 5") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and SA Associates, a California corporation ("Consultant") (collectively, the "Parties") is hereby made effective as of the date of the last authorized representative signature below ("Effective Date").

## RECITALS

A. On June 9, 2021, the City and Consultant entered into an agreement for professional services for the Consultant to provide project management consultant services ("Original Agreement").

B. On July 20, 2021, the Parties entered into Amendment No. 1 to the Original Agreement.

C. On October 19, 2021, the Parties entered into Amendment No. 2 to the Original Agreement.

D. On March 1, 2022, the Parties entered into Amendment No. 3 to the Original Agreement.

E. On June 1, 2022, the Parties entered into Amendment No. 4 to the Original Agreement.

F. The Original Agreement, as amended by Amendment No. 1, Amendment No. 2, Amendment No. 3, and Amendment No. 4 is referred to as the "Agreement."

G. The Parties now desire to amend the Agreement to increase the maximum compensation to be paid to Consultant under the Agreement (the "Maximum Compensation").

NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:

<u>Section 1.</u> Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$330,000, for a new Maximum Compensation of \$ 729,400.

<u>Section 2.</u> Exhibit B of the Agreement is hereby amended to reflect the amendments in Section 1 of this resolution regarding Maximum Compensation, to reflect the total not-to-exceed amount of \$729,400.

<u>Section 3.</u> Except as specifically amended by this Amendment No. 5, all other provisions of the Agreement shall remain in full force and effect.
