## AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND KOA CORPORATION

This First Amendment ("Amendment No. 1") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and KOA Corporation, a California corporation ("Consultant") (collectively, the "Parties") is hereby entered into as of September 6, 2022 ("Effective Date").

#### **RECITALS**

- A. On September 9, 2021, the City and Consultant entered into an agreement for professional services for the Consultant to provide design services for the Slurry Seal Areas 6 & 7 Project Striping ("Agreement"); and
- B. The Parties now desire to amend the Agreement to increase the maximum compensation to be paid to Consultant (the "Maximum Compensation"), extend the term, and modify the Scope of Services and Approved Fee Schedule.
- NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:
- <u>Section 1.</u> Section 2 of the Agreement is hereby amended to extend the term of the Agreement through December 31, 2024, unless sooner terminated as provided in Section 12 of the Agreement.
- <u>Section 2.</u> Section 3.A of the Agreement is hereby amended to increase the Maximum Compensation amount by \$31,920, for a new Maximum Compensation of \$79,900.
- <u>Section 3.</u> Exhibit A ("Scope of Services") of the Agreement is hereby amended to add the attached Exhibit A of this Amendment No. 1.
- <u>Section 4.</u> Exhibit B ("Approved Fee Schedule") of the Agreement is hereby amended to add the attached Exhibit B of this Amendment No. 1.
- <u>Section 5.</u> Except as specifically amended by this Amendment No. 1, all other provisions of the Agreement shall remain in full force and effect.

## EXHIBIT A SCOPE OF SERVICES

The primary services include, but are not limited to the following:

### Task 1 – Scoping Meeting with City Staff

The KOA Project Manager Shirjeel Muhammad, MS, PE will meet with the City's Project Manager to review the project requirements and expectations. KOA will provide the City with a project schedule prepared in MS Project showing the productions and review periods, with final plans and specifications delivery in 28 working days after the Agreement's effective date. KOA will prepare minutes of the meeting documenting the decisions made and directions provided by the City and will submit the minutes to the City's project manager for review and comments.

#### Deliverables:

- Kickoff meeting agenda and minutes
- Project Schedule
- Monthly invoices

### Task 2 – Base Map Development

KOA will utilize recently screened aerial photography as a base map for the striping plans. We would also utilize the City provided GIS files for the same if available. We will provide two segments of street on each plan sheet at a 1" =40' scale.

#### Deliverables:

Base maps in AutoCAD and PDF

#### Task 3 – Field Verification

Existing striping initial layout will be derived from aerial photography. KOA may deploy staff to the project locations to verify existing striping, painted curb, and raised markers. The base maps will be edited as necessary to reflect field conditions.

## Task 4 – Draft Striping Plans

KOA will prepare draft striping plans for the designated slurry seal streets as described in the RFP:

- Revise striping plans from recently completed Slurry Seal construction to separate those project areas already completed in FY 2021/22 in a separate set from Construction planned to be completed in FY 2022/23
- Striping plans for City Parking Lot 6 (1321 Highland Ave)

- Striping plans for Manhattan Beach Unified School District Grandview Elementary School Parking Lot (455 24th St)
- Additional effort to incorporate bike lane field additions to the record drawings for FY 2021/22
- Any additional plan modifications to incorporate bike lanes into the construction plans for FY 2022/23
- Additional hours for field verification.

We will submit these to City staff for review and comment. Plans will be prepared in accordance with City Standards, CA-MUTCD and Caltrans Standard Plans and Specifications.

#### **Deliverables:**

• Design plans, including title sheet, detail sheet, plan sheets in AutoCAD and PDF

## Task 5 – Final Striping Plans and Specifications

KOA will edit the plans based on City comments and will submit the final revised striping plans for City's use, in AutoCAD and pdf formats. The plans will be signed and sealed by a Civil Engineer registered in California. KOA will provide any additional technical specifications for the striping to be incorporated in the City's boilerplate bid documents.

#### Deliverables:

- Design plans, including title sheet, detail sheet, plan sheets in AutoCAD and PDF (Signed & Sealed)
- Specifications in MS Word with final signature and seal of the entire specifications (including City boilerplate specifications)

#### Task 6 – Construction Phase Services

KOA will coordinate with the City and Contractor to schedule field visit so to verify the Cat-Tracks prior to permanent striping application. Upon completion of the project, KOA will prepare record striping drawings.
