Craig Cadwallader, resident and representing the Surfrider Foundation Southbay Chapter, provided information regarding the use of polystyrene products and AB 2779 which would require the lid to be tethered to the container.

Community Development Director McIntosh responded to City Council questions.

City Attorney Barrow clarified that as part of a Business License the Business has to certify that they are not using these products. The ordinance will return to the City Council with Staffs' recommendations, except with regard to raw meat and fish trays. The Environmental Task Force will consider the amendment to the motion concerning cost analysis and enforcement.

A motion was made by Mayor Pro Tem Napolitano, seconded by Councilmember Lesser, to adopt Staff recommendations and prepare an Ordinance to do the following: Prohibiting Plastic Straws, Utensils and Stirs; Ban Polystyrene Produce Trays and Egg Cartons, and postpone moving forward with the ban on Raw Meat Polystyrene Trays.
