

NOTICE OF A PUBLIC HEARING BEFORE THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH TO CONSIDER A GENERAL PLAN AMENDMENT TO ADOPT THE MOBILITY PLAN UPDATE AND ADOPT A NEGATIVE **DECLARATION**

A public hearing will be held before the City Council for the project described below.

Applicant: City of Manhattan Beach

Filing Date: November 7, 2012

Property Location: The project encompasses the enitre jurisdictional boundary of the City of Manhattan Beach,

Los Angeles County, California.

Project Description: The City of Manhattan Beach has prepared a draft update to the circulation components of the

2003 General Plan Infrastructure Element. The circulation component has been renamed the Mobility Plan, with the key objective to provide a balanced, multimodal transportation system for the movement of people and goods within, to, and from the City. Pursuant to State laws and regulations, the proposed Mobility Plan is intended to meet the requirements of a circulation element, as defined in Section 65302 of the Government Code, while integrating multimodal transportation network policies into the General Plan. The Mobility Plan reflects the City's greater emphasis on accommodating non-motorized modes of transportation (bicycling and walking), as well as implementing "Complete Streets" concepts and emphasizing "Living Streets" by providing high-quality pedestrian, bicycling, and transit access to all destinations throughout the City. The proposed Mobility Plan is a policy and regulatory-level document that does not include any development proposal or infrastructure project. The recommendations in the Mobility Plan are intended to be used as guidance for the City in implementing

improvements described at undetermined times in the future.

Environmental

The Initial Study Checklist prepared for the project recommends that the lead agency adopt a Determination: Negative Declaration for the project. The City prepared a Negative Declaration, which was

posted for a 30 day public review and comment period from December 14, 2017 to January 15,

2018. The City recommends adoption of the Negative Declaration.
