AMENDMENT NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND GILLIS & PANICHAPAN ARCHITECTS, INC.

This Second Amendment ("Amendment No. 2") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Gillis & Panichapan Architects, Inc., a California corporation ("Consultant") (collectively, the "Parties") is hereby entered into as of October 16, 2018 ("Effective Date").

RECITALS

- B. On July 15, 2018, the City and Consultant amended the Original Agreement to increase the Maximum Compensation and extend the term of the Agreement ("Amendment No. 1").
- C. The Parties now desire to amend the Agreement, as amended by Amendment No. 1, to add additional services, and to increase the Maximum Compensation to pay for the additional services. The Original Agreement, as amended by Amendment No. 1, is referred to herein as the "Agreement."
- NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:
- <u>Section 1.</u> Section 3.A of the Agreement is hereby revised to increase the Maximum Compensation amount by \$24,450.00, for a new Maximum Compensation of \$73,375.00.
- <u>Section 2.</u> Exhibit A of the Agreement is hereby revised by adding the attached Exhibit A of this Amendment No. 2 to reflect the additional work.
- <u>Section 3.</u> Except as specifically amended by this Amendment No. 2, all other provisions of the Agreement shall remain in full force and effect.
