

RESOLUTION NO. 18-0161

A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL TO AWARD A CONSTRUCTION CONTRACT TO ELECNOR BELCO ELECTRIC INC (BELCO) FOR THE PEDESTRIAN SAFETY IMPROVEMENTS PROJECT ON HIGHLAND AVE AT 34TH, 35TH AND 36TH STREETS, AND ON MANHATTAN BEACH BLVD AT MORNINGSIDE DR; AUTHORIZE THE CITY MANAGER TO APPROVE ADDITIONAL WORK, IF NECESSARY; APPROVE THE PLANS AND SPECIFICATIONS FOR THE PEDESTRIAN SAFETY IMPROVEMENTS PROJECT; APPROVE THE RE-APPROPRIATION OF \$40,000 FROM THE 14/15 NON-MOTORIZED TRANSPORTATION CROSSWALKS & BIKE LANES PROJECT; APPROVE THE RE-APPROPRIATION OF \$110,000 FROM THE FY15/16 ANNUAL CURB, GUTTER AND RAMP REPLACEMENT PROJECT; AND APPROVE THE REAPPROPRIATION OF \$140,000 FROM THE AMERICANS WITH DISABILITIES ACT (ADA) TRANSITION PLANS WITHIN PUBLIC RIGHTS-OF-WAY PROJECT

THE MANHATTAN BEACH CITY COUNCIL HEREBY RESOLVES AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute a contract in the amount of \$263,572 with Elecnor Belco Electric, Inc., for the Project and is further authorized to approve additional work, if necessary, in an amount not-to-exceed \$26,428.

SECTION 2. The City Council hereby approves the plans and specifications for the Pedestrian Safety Improvements Project ("Project") on Highland Ave at 34th, 35th and 36th Streets and on Manhattan Beach Blvd at Morningside Dr., and approves the Agreement between the City and Elecnor Belco Electric, Inc., dated December 4, 2018 for the Project.

SECTION 3. The City Council hereby approves the re-appropriation of \$40,000 in the Capital Improvement Program (CIP) Fund from the FY14/15 Non-Motorized Transportation Crosswalks & Bike Lanes Project to the Pedestrian Safety Improvements Project.

SECTION 4. The City Council hereby approves the re-appropriation of \$110,000 in the Gas Tax Fund from the FY15/16 Annual Curb, Gutter and Ramp Replacement Project to the Pedestrian Safety Improvements Project.

SECTION 5. The City Council hereby approves the re-appropriation of \$140,000 in the Measure M Fund from the ADA Transition Plan Within Public Rights-of-Way Project to the Pedestrian Safety Improvements Project.

SECTION 6. The City Clerk shall certify to the passage and adoption of this Resolution.
