TERMS & CONDITIONS

QUOTATIONS

- 1. Prices quoted to U.S. customers are in U.S. funds; Canadian customers in Canadian funds.
- 2. To quoted prices add any applicable taxes and duties.
- 3. Quotations are valid for 30 days unless otherwise stipulated.
- 4. All square foot pricing is invoiced to the next even dimensional inch and incorporates a 5 square foot minimum per piece.
- 5. Standard boxing is based on 2,000-pound cases. Special boxing is available provided all requirements are submitted at the time of initial order and may be subject to additional charges.

SAMPLES

1. Samples are provided as stipulated on the respective quote. Extra charges may apply for any additional sample(s) unless previously arranged.

CHANGE ORDERS

1. Change orders, add-ons or replacement orders will be re-quoted. If the original order is already in production, charges will be invoiced for costs incurred up to the terminated point of production. Please contact your Goldray account manager.

PRODUCTION & QUALITY ASSURANCE

- 1. All products requiring heat treatment will be processed through a horizontal tempering furnace to ensure all roller wave runs parallel to the width dimension. For orders that contain pieces which exceed 84" in width, roller wave requirements must be established prior to production.
- 2. Goldray cannot accept templates. Custom shapes must be submitted as a CAD file or shop drawing with geometric representation.
- All goods, including those produced to meet an exact specification, shall be subject to tolerances and variations consistent with the usage of trade, regular factory practices and practical testing and inspections methods unless otherwise agreed in writing by Goldray.

FREIGHT & DELIVERY

- Prices and set up charges are based on one order, one shipment. Multiple releases shall be subject to additional set up and/or freight charges unless otherwise stated.
- 2. Orders are quoted FOB Goldray, Calgary, unless stated otherwise in writing. Purchasers take ownership of orders at the Goldray Calgary plant.
- 3. Goldray may arrange for freight and export fees at the purchaser's request. Any freight charges will be quoted separately.
- 4. Where Goldray arranges to ship goods for the customer, delivery is based on dry van delivered to warehouse dock. Site deliveries may be arranged to commercial locations only if conditions permit and must be coordinated at time of purchase order. No liability for job site deliveries will be assumed by Goldray Industries Ltd., i.e.: damages to premises, equipment etc.
- 5. Any non-standard delivery or arrangements will be the responsibility of the purchaser and will be quoted separately upon request.

TERMS, CREDIT & US TAXES

- All purchase orders are received on a cash basis unless Buyer has established a satisfactory credit account. Goldray may, in its sole discretion, agree
 to grant credit terms to the buyer after a credit application is completed and processed. Goldray will not be liable to Buyer for any refusal to grant credit.
- 2. A 30% deposit is required on all orders regardless of prearranged credit terms and must be received prior to production unless otherwise agreed upon in advance.
- 3. Once an account has been established, Goldray's credit terms are net 30 days from the date of invoice, unless otherwise agreed upon. Any credit terms are subject to Goldray's continuing approval of Buyer's credit. If in Goldray's sole discretion, Buyer's credit or financial standing become unsatisfactory, Goldray may withdraw or modify the credit terms. Goldray may, at its discretion, offer early payment discounts, contact your sales rep for details.
- Overdue accounts will be charged interest at the rate of 1.5% per month. Buyer shall be responsible for Goldray's costs of collection including reasonable attorney's fees in the event of nonpayment.
- 5. Goldray is not a collector of US or state taxes. As the title for products transfers upon delivery to a foreign destined common carrier, the responsibility for such taxes falls on the purchaser.

DAMAGED MATERIALS AND CLAIMS

- 1. For your own protection, if there is damage to the crate or breakage to the glass, please note this information on the bill of lading, provide a photograph and forward it to Goldray Industries immediately. Goldray will submit a freight claim with the carrier on your behalf. If any damage is not noted on the bill of lading at the time of delivery, the ability to file a claim against the shipper is lost.
- Any damage hidden within the crate must be reported to Goldray Industries within 48 hours and include the bill of lading with damages noted and a photograph of the damage.

STORAGE

- 1. All glass products, whether crated or uncrated, must be stored indoors in a clean, dry area and protected from the elements.
- 2. Refrain from the excessive moving of glass or crates which may also cause damage from friction or vibration.
- 3. Goldray's warranty is void for any glass that is damaged due to improper storage or handling.

WARRANTY

- 1. Goldray provides a limited warranty. Its terms are set out in our separate warranty certificate available upon request.
- Glass breakage, including spontaneous breakage in tempered glass, is specifically excluded from all Goldray product warranties. Goldray warrants glass from date of manufacture.
- 3. Goldray will not accept any charge or expense, including labour, for modification, removing, inspecting or installing the goods. Goldray's warranty will be void if full payment is not received for goods and services within the agreed-upon terms of sale.
- 4. Goldray expressly disclaims any implied warranty of merchantability or fitness for any particular purpose and any other obligation or liability not expressly set forth in its standard terms of the warranty. Goldray shall not be liable for incidental or consequential damages.
