## **RESOLUTION NO. 19-0033**

A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, MARCH 5, 2019, DECLARING THE RESULT AND STATEMENT OF THE VOTE

WHEREAS, a General Municipal Election was held and conducted in the City of Manhattan Beach, California, on Tuesday, March 5, 2019, as required by law;

WHEREAS, a notice of the election was given in time, form, and manner as provided by law; voting precincts were properly established, election officers were appointed as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities;

WHEREAS, in all respects, the election was held and conducted, the votes were cast, received, and canvassed, and the returns made and declared in time, form, and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities;

WHEREAS, The Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council. The results are received, attached, and made part hereof as Exhibit A.

THE MANHATTAN BEACH CITY COUNCIL HEREBY RESOLVES AS FOLLOWS:

<u>SECTION 1</u>. The whole number of ballots cast in the precincts except Vote-By-Mail ballots were 2,326. The whole number of Vote-By-Mail ballots cast in the City was 4,862. The total number of ballots cast in the City was 7,188.

<u>SECTION 2</u>. The names of persons voted for at the election for Member of the City Council are as follows:

Suzanne Hadley Wayne Powell Joe Franklin Brian Withers Mark Burton Joseph A. Ungoco Hildy Stern

SECTION 3. The question presented on the ballot was as follows:

**Measure A: Manhattan Beach's Quality of Life Measure**. To fund To fund essential City services such as police patrols/crime prevention, fire, paramedic/9-1-1 emergency response, street maintenance, pothole repair, community facilities, infrastructure improvements/other general services, shall an

ordinance be adopted increasing the City's existing transient occupancy (hotel) tax paid by hotel/motel guests up to 14%, providing more than \$1,000,000 annually for City services, until ended by voters, requiring citizen oversight, independent audits, and all funds locally controlled?

<u>SECTION 4</u>. The number of votes given at each precinct and the number of votes given in the City to each of the persons listed in Section 2 named for the respective offices for which the persons were candidates are as listed in Exhibit A attached.

SECTION 5. The number of votes cast at the election, according to the Canvass, were more than seventy-six percent in favor of the question presented. The measure only required approval of fifty percent plus one of voters casting a ballot. As a result, the qualified electors approved Measure A and the increase to the transient occupancy tax paid by hotel/motel guests, as described in Section 3.

<u>SECTION 6</u>. The City Council does declare and determine Suzanne Hadley and Hildy Stern were elected as Members of the City Council for the term of three years and eight months.

SECTION 7. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) The measure voted upon; (4) For what office each person was voted for; (5) The number of votes given at each precinct to each person and for and against the measure; and (6) The number of votes given in the City to each person and for and against each measure.

<u>SECTION 8</u>. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
