A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL ACKNOWLEDGING RECEIPT OF A REPORT MADE BY THE FIRE CHIEF REGARDING COMPLIANCE WITH THE ANNUAL INSPECTION OF CERTAIN OCCUPANCIES PURSUANT TO SECTIONS 13146.2 and 13146.3 OF THE CALIFORNIA HEALTH AND SAFETY CODE

WHEREAS, California Health & Safety Code Section 13146.4 was added in 2018, and became effective on January 1, 2019; and

WHEREAS, California Health & Safety Code Section 13146.4 requires that all fire departments, including Manhattan Beach Fire Department, that provide fire protection services report annually and present to its administering authority on its compliance with Health & Safety Code Sections 13146.2 and 13146.3; and

WHEREAS, California Health & Safety Code Sections 13146.2 and 13146.3 requires all fire departments, including Manhattan Beach Fire Department, that provide fire protection services by performing annual inspections in every building used as a public or private school, hotel, motel, lodging house, apartment house, and certain residential care facilities for compliance with building standards, as provided; and

WHEREAS, the Manhattan Beach City Council intends this Resolution to fulfill the requirements of the California Health & Safety Code Section 13146.4 regarding acknowledgment of the Manhattan Beach Fire Department's Fire Department's compliance with California Health and Safety Code Sections 13146.2 and 13146.3; and

WHEREAS, the Manhattan Beach City Council expressly acknowledges the measure of compliance of the Manhattan Beach Fire Department with Health and Safety Code Sections 13146.2 and 13146.3 in the City of Manhattan Beach for the time period of July 1, 2018 to June 30, 2019.

THE MANHATTAN BEACH CITY COUNCIL HEREBY RESOLVES AS FOLLOWS

<u>SECTION 1</u>. Educational Facilities, for the purposes of this Resolution, are generally those public and private schools/facilities, for educational purposes through the 12th grade. Manhattan Beach Fire Department completed 77% of the annual inspections of the identified Educational buildings, structures and/or facilities within the City of Manhattan Beach.

<u>SECTION 2</u>. Residential occupancies, for the purposes of this Resolution, are generally those occupancies containing sleeping units, and include hotels, motels, apartments (three units or more), etc. as well as other residential occupancies, Fire prevention identified an additional 318 buildings that meet this

criteria within the City limits. These residential and/or care facilities have a number of different sub-classifications, and they may contain residents or clients that have a range of needs, including those related to custodial care, mobility impairments, cognitive disabilities, etc. The residents may also be non-ambulatory or bedridden. Manhattan Beach Fire Department completed 99% of the annual inspections of the identified occupancies, apartments (three units or more), structures and/or facilities in the City of Manhattan Beach.

<u>SECTION 3</u>. The City Clerk shall certify to the passage and adoption of this resolution.
