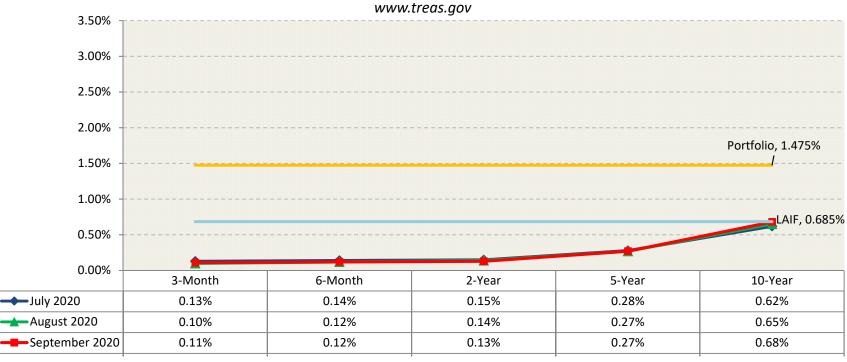

Pooled Money Investment Account Monthly Portfolio Composition (1) 08/31/20 \$113.8 billion

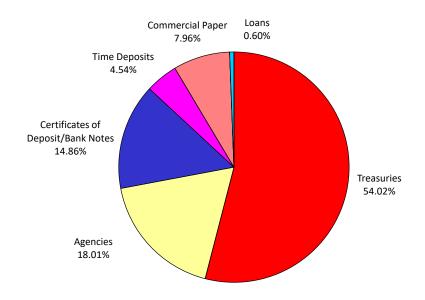
