#### **INTRODUCE ORDINANCE NO. 20-0006**

AN ORDINANCE OF THE CITY OF MANHATTAN BEACH AMENDING MANHATTAN BEACH MUNICIPAL CODE CHAPTER 4.120 TO LIMIT THE USE OF CITY RESOURCES IN CAMPAIGNS AND PROVIDE FOR ADJUSTMENTS ON THE LIMITS FOR CAMPAIGN CONTRIBUTIONS IN MUNICIPAL ELECTIONS.
