# AMENDMENT NO. 4 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF MANHATTAN BEACH AND MICHAEL BAKER INTERNATIONAL, INC.

This Fourth Amendment ("Amendment No. 4") to that certain agreement by and between the City of Manhattan Beach, a California municipal corporation ("City") and Michael Baker International, Inc., a Pennsylvania corporation ("Consultant") (collectively, the "Parties") is hereby entered into as of April 20, 2021 ("Effective Date").

#### RECITALS

- A. On January 3, 2017, the City and Consultant entered into an agreement for professional services for the Consultant to provide design services for the Aviation Boulevard to Artesia Boulevard Southbound to Westbound Right Turn Lane Improvement Project ("Agreement");
- B. On August 8, 2018, the Parties entered into Amendment No. 1 to the Original Agreement.
- C. On July 8, 2019, the Parties entered into Amendment No. 2 to the Original Agreement.
- D. On December 22, 2020, the Parties entered into Amendment No. 3 to the Original Agreement. The Original Agreement, as amended by Amendment No. 1, Amendment No. 2 and Amendment No. 3 is referred to herein as the "Agreement".
- E. The Parties now desire to amend the Agreement to increase the Maximum Compensation and modify the Scope of Services.
- NOW, THEREFORE, in consideration of the Parties' performance of the promises, covenants, and conditions stated herein, the Parties hereby agree as follows:
- <u>Section 1.</u> Section 3.A of the Agreement is hereby revised to increase the Maximum Compensation amount by \$32,240.00, for a new Maximum Compensation of \$252,781.00.
- <u>Section 2.</u> Exhibit A (Scope of Services) of the Agreement is hereby amended to include additional services by adding the services set forth on the attached Exhibit A (Scope of Services) attached to this Amendment No 4. Exhibit B (Approved Fee Schedule) of the Agreement is hereby amended by adding the attached Exhibit B (Approved Fee Schedule) of this Amendment No. 4 to the Approved Fee Schedule.
- <u>Section 3.</u> Except as specifically amended by this Amendment No. 4, all other provisions of the Agreement shall remain in full force and effect.

### EXHIBIT A SCOPE OF SERVICES

#### **DESCRIPTION OF ADDITIONAL SERVICES**

#### Item #1: Meetings

Michael Baker's project manager and project engineer will attend the preconstruction meeting with the Contractor, City, and Construction Inspector and be available to answer any design related questions. This will be helpful in the knowledge transfer from the design to the construction team.

Michael Baker's project manager and project engineer will visit the site twice during the construction phase. This will help resolve any challenges that the Contractor and Inspector need to resolve.

#### Item #2: Answer Contractor RFIs during Construction

Michael Baker will respond to design-related Requests for Information (RFIs) during the construction process. Michael Baker will review design-related submittals, shop drawings, and requests for change orders. The City's construction inspector will still assume responsibility for reviewing all submittals and shop drawings against the project plans and specifications. Michael Baker will prepare any necessary delta revisions on the plans during construction under this task.

#### Item #3: Prepare As-Built Plans

Michael Baker will prepare As-Built plans after construction is complete, based upon the information provided by the Construction Management (CM) team, and based upon changes made to the plans during construction (Delta Revisions). These as-built plans will be provided to the City for their files.

Tasks are to be performed per the City's request only.
