**RECOMMENDATION:**  
Staff recommends that City Council adopt Ordinance No. 17-0016.

**FISCAL IMPLICATIONS:**  
There are no fiscal implication associated with adopting informal bidding procedures, although there are potential future savings in project implementation.

**BACKGROUND:**  
On July 18, 2017, the City Council introduced Ordinance No. 17-0016 (Attachment 1). The ordinance, once adopted, authorizes the City to utilize the alternative bidding procedures outlined in the UPCCAA when implementing public projects as defined in Public Contract Code § 22000 - 22045. This will allow staff to expedite implementation of smaller capital and repair projects, thereby

saving time, money and resources.

**PUBLIC OUTREACH/INTEREST:**

The Ordinance was considered at two duly noticed public meetings.

**ENVIRONMENTAL REVIEW**

The City has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA) and has determined that the activity is not a "Project" as defined under Section 15378 of the State CEQA Guidelines; therefore, pursuant to Section 15060(c)(3) of the State CEQA Guidelines the activity is not subject to CEQA. Thus, no environmental review is necessary.
