APPOINT

RECOMMENDATION:

Staff recommends that the City Council appoint members to the Bruce's Beach Task Force.

FISCAL IMPLICATIONS:

There are no fiscal implications associated with the recommended action.

BACKGROUND:

On September 1, 2020, City Council directed staff to collect applications for Manhattan Beach residents to serve on a task force to address the history of Bruce's Beach. Staff opened the application on September 2, 2020, and received over 100 applications from residents by the time the application period closed on October 2, 2020. 79 interviews were conducted on October 13, 2020.

DISCUSSION:

City Council can make at least nine appointments to the Task Force, but it can be expanded at their discretion.
